As Term 4 gets underway, I would like to take this opportunity to provide an update on the work of the School Curriculum and Standards Authority (the Authority).

Adopting and Adapting the Australian Curriculum version 9 in the Western Australian Curriculum and Assessment Outline

We are continuing our work to adopt and adapt the Australian Curriculum Version 9 within the *Western Australian Curriculum and Assessment Outline*. The Western Australian curriculum for the English and Health and Physical Education learning areas will be available for familiarisation in 2024 and implementation in 2025. Other learning areas will be starting consultation in 2024. Details of the consultations will be communicated to schools early in 2024.

ACARA NAPLAN 2023 survey

As you know, NAPLAN moved from May to March this year, and changes were made to reporting to provide simpler, clearer, and more meaningful results. ACARA is keen to hear from principals and teachers, as well as parents and carers, on these changes.

ATAR course examinations

The ATAR course examinations are a key moment for many students. Students completing practical examinations through portfolios and productions submitted their work in September. The practical (performance and oral) examinations for ATAR courses began on 23 September and ended on 22 October. The ATAR course written examinations begin on Monday, 30 October and run through until Friday, 17 November.

I would like to acknowledge teachers and school communities for the care they have taken in preparing students for the examinations and the support they provide throughout the examination period. I also thank the hundreds of teachers who are involved in the marking process. Teacher involvement is central to the success and integrity of the examinations process. To all students in secondary schools enrolled in ATAR courses, I wish them all the best in their examinations.

I am pleased to congratulate Juanita Healy on her appointment as Executive Director – School Curriculum and Standards.

Juanita brings a wealth of curriculum and assessment experience, across Kindergarten to Year 12, to the role and a student-centred focus on all aspects of her work.
