



## Endorsed Programs WACE requirements Special Consideration for Year 12 students in 2021

Schools may apply to the School Curriculum and Standards Authority (the Authority) on behalf of a student who, for reasons outside of their control, has not been able to meet WACE requirements due to issues involving an endorsed program by the end of Year 12.

The WACE Special Considerations Committee considers each application separately and the Authority will notify the school of the decision.

### Eligible students

Schools may make an appeal on behalf of a student (if the student has been enrolled in an endorsed program) for an exemption from meeting WACE requirements affected by issues involving endorsed programs in the following situations:

1. The student has been adversely affected by unforeseen complications in a school/employer or provider partnerships
2. The student has been transferred from overseas or is in a remote and/or regional area where there is an absence, or very restricted supply of alternative endorsed programs options and viable partnerships.

### Special consideration process

#### Written submission

Schools must provide a submission to the Authority if:

- (a) the student will meet all other requirements for WACE by the end of Year 12 in 2021,
- (b) the circumstances which have either impacted their endorsed programs achievement or prevented the student from completing an endorsed program by the end of Year 12 in 2021, and
- (c) the school has evidence that genuine attempts were made to rectify the issue and all suitable alternatives have been exhausted.
